

NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location:

Public Agency:	Rancho California Water District (RCWD)
Project Name:	Camino Sierra Pressure Zone Conversion (Project No. D1807)
Project Description:	The Project proposes the construction of approximately 8,200 LF of 12-inch and 8-inch diameter water distribution pipeline to convert an area of low service pressures (2070 PZ) to the adjacent 2350 PZ. The Project will improve water pressure along Camino Sierra Road and De Portola Road
Project Location – Identify street address and cross streets or attach a map showing project site (preferably a USGS 15' or 7 1/2' topographical map identified by quadrangle name):	The proposed Project is located in an unincorporated area of southwest Riverside County, east of the City of Temecula. The Project is located in the street right-of-way for Camino Sierra Road and De Portola Road, as well as an area along Geisbauer Road through an irrevocable offer of dedication (see attached map)

This Initial Study was completed in accordance with the Lead Agency's Guidelines for Implementing the California Environmental Quality Act. This Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. On the basis of such Initial Study, the Lead Agency's Staff has concluded that the project will not have a significant effect on the environment, and has therefore prepared a Draft Mitigated Negative Declaration. The Initial Study reflects the independent judgment of the Lead Agency.

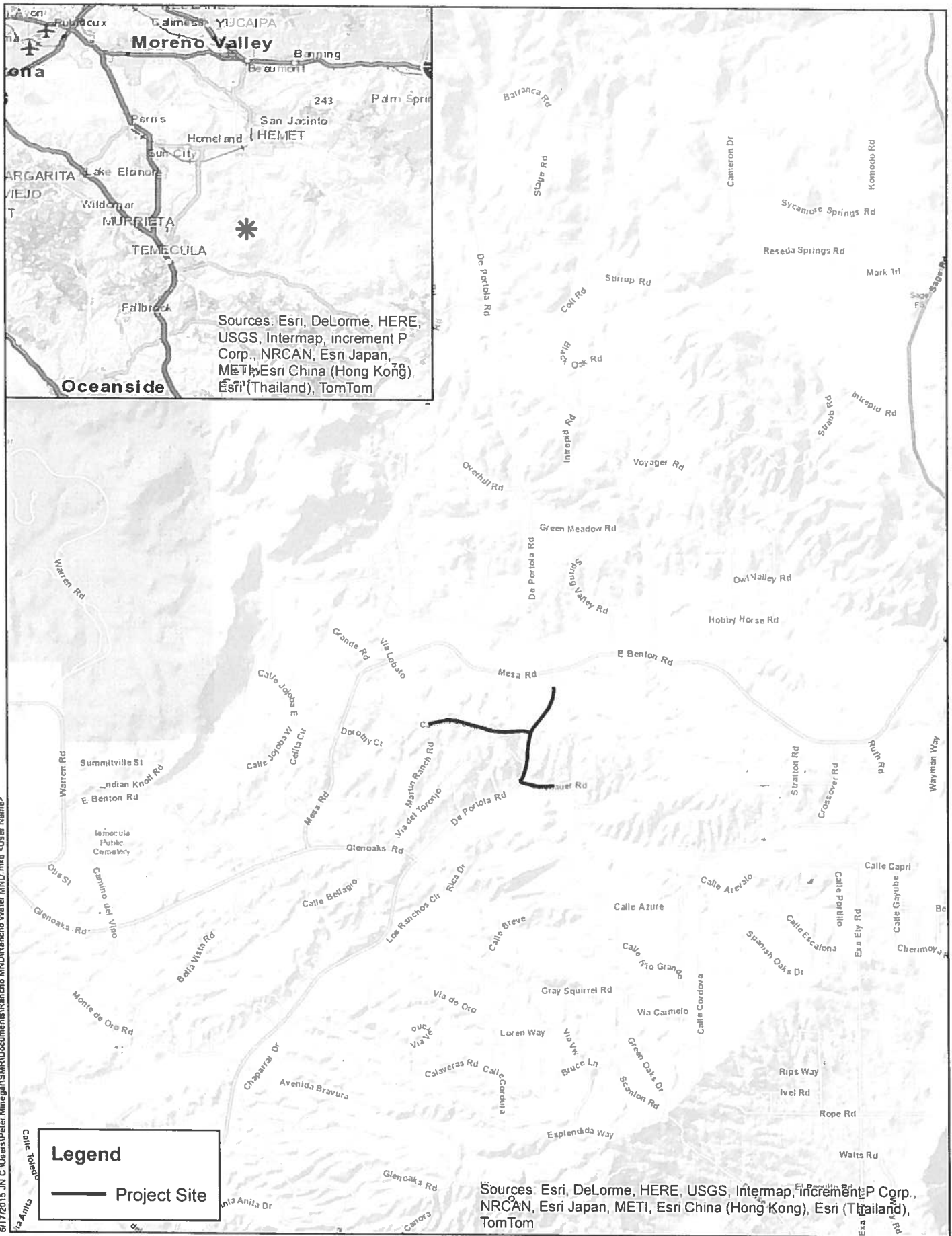
